Fort Shafter	This will be able to increase the quantity and quality of the drinking water to Fort Shafter and to keep up with rising demand at Fort Shafter. The current two wells date back to 1910 and are not sufficient to provide consistent water quantity and quality.	Honolulu County HI	\$23,000
Schofield Barracks	The water system is incapable of providing the require quantity at proper pressure. An increase in storage of elevated water and distribution line capacity coupled with a new pump station are required to meet current and future water demands.	Honolulu County HI	\$21,000
